<b>TERMS AND CONDITIONS</b>
-----------------------------

1. Fees paid cover tuition, the use of facilities offered by Zeidoros Arts Centre, seven nights accommodation in Kapsali apartments on Kythira, welcome drinks, mid-week beach meal in Agia Pelagia, end of course meal, and transfers (if required) from the island airport/ port on Sunday 2nd June and to island airport/port on Sunday 9th June 2019. Outside of these dates the cost of island transfers is not covered by AllcomersMusic.
2. Fees apply for the full course with seven nights accommodation. Applications for shorter periods than this will be charged at the full fee less the cost of accommodation for each night not attending (€30 per night for shared accommodation, €40 per night for single occupancy).
3. Choice of accommodation is subject to availability and will be confirmed separately. If you wish to amend your accommodation choice please notify us as soon as possible. We cannot guarantee that all requests will be fulfilled.
4. Your place will only be reserved once a completed application form and £120 deposit has been received. All fees must be paid in pounds sterling.
5. If we cannot initially offer you a place, we will put your name on the waiting list and hold your payment. We will notify you should a place become available. If you have been put on the waiting list, you may withdraw at any time and your payment will be returned to you in full.
6. An administration charge equivalent to any bank charges incurred by AllcomersMusic will be applied to bookings received from persons outside the UK.
7. If, having been accepted onto the course, we are advised of your cancellation by 31st March 2019 we will refund your fees, minus the £120 deposit. If you cancel your place after 31st March 2019 your fees will be forfeited unless we can fill your place.
8. It is essential, you insure any instrument and personal possessions you may be bringing, and also take out adequate holiday insurance. AllcomersMusic will not accept responsibility for loss of or damage to any personal possessions, however so caused, nor be liable for any loss suffered by you resulting from any event which is beyond the reasonable control of AllcomersMusic.
9. AllcomersMusic reserves the right to change without notice the tutors and course details.
10. AllcomersMusic shall accept no liability for any advice about travel arrangements or for the cancellation of the course due to insufficient bookings or any cause beyond our reasonable control.
